About INCODING

The aim of the INCODING project is to analyse the role of collective bargaining and other forms of employee involvement at workplace level in (co) governing the black box of AM with a view to identify the main challenges for workers and their representatives, and explore its contribution to Inclusive Algorithmic Management understood as the turn to more transparency in the design and implementation of AI based systems at company level and guaranteeing human oversight of automated processes.

The project is coordinated by the Universitat Autònoma de Barcelona | Sociological Research Centre on Everyday Life and Work – QUIT as leader of a consortium consisting of 5 partners including Centre for Social Innovation – ZSI (Austria), University of Copenhagen | Employment Relations Research Centre – FAOS (Denmark), WZB Berlin Social Science Center (Germany) and Centre for Social Sciences, Hungarian Academy of Sciences -TKSZI (Hungary).















Context and objectives of the event

As we are currently approaching the end of the project, the aim of the Final conference is to present our findings and enter into a debate on how to tackle the challenge that algorithmic management and the use of A.I. presents for social actors, managers and workers.

As we have seen through the course of the last years, the question on how to regulate technology at the workplace has become more and more important: social partners have already addressed the matter in an increasing number of collective agreements and different governments like those of Spain, Germany and the European Commission are modernizing their legislation or are currently debating on how to keep up with the challenge. In our final conference, insights on these and other developments will be shared and debated by researchers, social partners, and stakeholders from the field.

The conference, convened by the INCODING Project team, Dr Oscar Molina (UAB), Dr Ursula Holtgrewe (Austria), Dr Florian Butollo (Germany), Prof Csaba Makó (Hungary), and Dr Trine Pernille Larsen and Dr Anna Ilsøe (Denmark), will feature keynote address by Dr Aída Ponce Del Castillo, senior researcher of ETUI, as well as contributions by key organisations, alongside young researchers and leading academics from Europe.

The conference is open for researchers, social partners, companies, representatives from national and/or regional governments, and anyone else that is interested in the topic of use of algorithms and A.I.-based technologies in the workplace.
